INTRODUCTORY NOTE: In response to welfare reform, the state of Ohio established the Prevention, Retention and Contingency (PRC) program as a way of reinvesting welfare (TANF) dollars at the local level, demanding greater community involvement of public and private community-based organizations, schools, and local employers. In its summary of PRC Programs, the Ohio Department of Job and Family Services states, "The old system was reactive, responding to needs after the situation had become drastic. The new system is proactive, looking forward to prevent and strategically intervene when the investment of resources can forestall long-term dependency." While still tending to contingent, one-time urgent family needs, the program is built around outcomes-focused models envisioned and implemented on the county level. A \$40 million TANF surplus from January 2000 to June 2001 allowed Ohio to expand the program to include the PRC Development Reserve (PRC-DR), a funding pool specifically aimed at generating new collaborations with nontraditional partners. Through the PRC-DR program, Ohio made a deliberate attempt to partner with faith-based organizations, overseeing the establishment of over seventy new faith-based collaborations. Combined, recent PRC and PRC-DR faith-based contracts total over \$21 million dollars. Such substantial growth has made necessary the organization of a faith-based taskforce, which will monitor these many new collaborations and explore further ways the faith community might be utilized as a community-building partner.

County Department of Job and Family Services, comments, "Good Works, Inc. is a faith based organi-

zation providing a host of services, including both short term and long term housing services. They counsel folks on budgeting, alcohol/drug addictions, and domestic violence. In addition, they also run various support groups. We contracted with Good Works the last several years to provide education and training services for clients."

Jeff Bush is particularly vocal about the \$9 million cut in TANF funding Athens County recently suffered. He writes, "The programs that were lost [including all faith-based organizations] provided vital support for working poor families that face a daily struggle to remain off welfare. Such vital support is not merely a good financial investment in the success of welfare reform. Such vital support fulfills a moral and contractual obligation that was created by the state with welfare reform. The families that took responsibility for their own self-sufficiency by accepting low paying jobs are owed these supportive services that allow them to maintain a minimally acceptable quality of life." Due to the "budget decisions of the Governor and General Assembly" in response to the public education funding crisis, most, if not all, of Athens County's programs have been terminated. "The faith-based community," Bush reports, "is being hit hard and it will only continue to worsen, especially if the economy continues to slow."

Points to Note: This agency held an identical contract for July 1999-June 2000. Bush comments, "NHN strives to bring together representatives from local churches to share information and resources. In addition, many of the churches have decided to pass on their emergency assistance funds to NHN for screening and distribution to those in need. This has been beneficial to churches because they can direct those in need to one central screening/assistance site, eliminating duplication of efforts which has been a problem for many years. Furthermore, most of the churches do not have full-time staffing at the church to assist those in need, so the change has been very beneficial to our clients as well in terms of easy access and coordination of services. In addition, we also contracted with NHN to provide summer congre-

gate meal sites in several locations in Athens County primarily serving low-income children. These

were well attended."
